**F&B STAFF CHARGE AND F&B HOUSE CHARGE**

An 18.75% F&B Staff Charge, a 6.25% F&B House Charge, plus applicable taxes (currently 8.5%), are applied to all buffet services, beverage and hosted bar services, reception service and coffee breaks. All fees are subject to change.

A 14.625% F&B Staff Charge, a 10.375% F&B House Charge, plus applicable taxes (currently 8.5%) are applied to all plated services. All fees are subject to change.

A 16.5% F&B Staff Charge, an 8.5% F&B House Charge, plus applicable taxes (currently 8.5%) are applied to all cash bar services. All fees are subject to change.

A 3.75% F&B Staff Charge, a 21.25% F&B House Charge, plus applicable taxes (currently 8.5%) are applied to all meeting room rental with food and beverage services in the room. For rooms without food and beverage, an additional 14% occupancy tax is applied. All fees are subject to change.

*The F&B House Charge is used to offset the costs of utilities and equipment, and other non-labor expenses. This F&B House Charge is not a tip or gratuity for services provided by employees and is not distributed to employees. Banquet personnel are not customarily tipped, so tips are not expected.*

**FOOD & BEVERAGE MINIMUM REVENUE REQUIREMENT**

Ligue Henri IV agrees that it will provide a **minimum food and beverage revenue of \$104,000.00++ (exclusive of applicable service charges and taxes)**. Should Ligue Henri IV not meet the guaranteed food and beverage requirement, any difference between the guarantee and the actual food & beverage revenue will be assessed as additional room rental. In addition, if any food and beverage event is cancelled within 72 hours of its scheduled starting time, Ligue Henri IV agrees to pay Hotel 100% of the food and beverage revenue guaranteed at 72 hours.

**ACCEPTANCE**

Hotel and Ligue Henri IV have agreed to and have executed this Addendum by their authorized representatives as of the dates indicated below. In the case of any inconsistencies between the original Agreement and Addendum, the terms of the Addendum shall apply. All other terms and conditions as stipulated in original Agreement signed and dated by Ligue Henri IV on May 23, 2017 remain in effect.
